ARTICLE 1  
Merging Corporations

## EXHIBIT A

### PLAN OF MERGER

This Plan of Merger sets forth the terms and conditions under which HomePNA, Inc., a California nonprofit mutual benefit corporation (“HomePNA”), will merge with and into HomeGrid Forum, an Oregon nonprofit mutual benefit corporation (“HomeGrid Forum”).

#### SECTION 1 DEFINITIONS

“Effective Time” means 12:01 a.m. on May 28, 2013.

“Merger Agreement” means the Merger Agreement dated May 24, 2013 between HomeGrid Forum and HomePNA.

#### SECTION 2 MERGING CORPORATIONS

The merging corporations will be HomeGrid Forum and HomePNA.

#### SECTION 3 SURVIVING CORPORATION

The surviving corporation will be HomeGrid Forum.

#### SECTION 4 MATERIAL TERMS AND CONDITIONS

- 4.1 **Merger.** At the Effective Time, HomePNA will merge with and into HomeGrid Forum and the separate existence of HomePNA will cease.
- 4.2 **Articles of Incorporation.** The Restated Articles of Incorporation of HomeGrid Forum (as amended) before the Effective Time will continue to be the Restated Articles of Incorporation of HomeGrid Forum (as amended) after the Effective Time.
- 4.3 **Bylaws.** The Fourth Amended and Restated Bylaws of HomeGrid Forum before the Effective Time will continue to be the Fourth Amended and Restated Bylaws of HomeGrid Forum after the Effective Time.
- 4.4 **Directors.** The individuals specified in the Merger Agreement as the directors of HomeGrid Forum after the Effective Time will be the directors of HomeGrid Forum after the Effective Time.
- 4.5 **Officers.** The officers of HomeGrid Forum before the Effective Time will continue to be the officers of HomeGrid Forum after the Effective Time.
- 4.6 **Merger Agreement.** This Plan of Merger is subject to the terms and conditions set forth in the Merger Agreement.

#### SECTION 5 CONVERSION OF MEMBERSHIPS

The manner and basis of converting the memberships of HomePNA into memberships of HomeGrid Forum has been agreed to by HomePNA and HomeGrid Forum and is set forth in the Merger Agreement.
